PARTICIPANT AGREEMENT, RELEASE AND ACKNOWLEDGEMENT OF RISK

In consideration of the services of New Life Martial Arts & Fitness, RMNU Hawaii, New Life Jiu-Jitsu, Kahana & Charleen Cordeiro, Sidney & Kauai Cordeiro, and New Life Jiu-Jitsu, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as “New Life Jiu-Jitsu” at the Solid Rock North Church, I hereby agree to release and discharge New Life Jiu-Jitsu on behalf of myself, my children, my parents, my heirs, assigns, personal representative(s) and estate as follows:

I acknowledge that participation in the martial arts entails unknown and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: intense stressful and strenuous exercises with body contact. I expressly consent to confront these known and unknown dangers and further agree, understand and recognize that these risks may result in serious injury or illness including but not limited to: bruises, bloody noses, broken bones, sprains, dislocations, heart attacks or other cardiovascular disease, or other serious injury resulting in death and/or property damage. Furthermore, New Life Jiu-Jitsu’ employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be ignorant of a participant’s fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

- I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
- I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless, New Life Jiu-Jitsu from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of New Life Jiu-Jitsu’ equipment or facilities, including any such claims which allege negligent acts or omissions of New Life Jiu-Jitsu.
- Should New Life Jiu-Jitsu, or anyone acting on their behalf, be required to incur attorney’s fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
- I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions which could interfere with my safety in this activity, or else I am willing to assume - and bear the costs of all risks that may be created, directly or indirectly, by any such condition.

In the event that I file a lawsuit against New Life Jiu-Jitsu, I agree to do so solely in the state of Hawaii, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state.

By signing this document, I acknowledge that if I, or any other person or persons, is hurt in any way, or property is damaged during my participation in this activity, I hereby waive any right to any claim and/or lawsuit against New Life Martial Arts & Fitness, RMNU Hawaii, New Life Jiu-Jitsu, Kahana & Charleen Cordeiro, Sidney & Kauai Cordeiro, and New Life Staff on the basis that any claim I may have is hereby released and acknowledged by my signature below.
